- November 5, 2018 Faculty Senate Meeting Minutes

A motion was made to approve the Minutes of the November 5, 2018 Faculty Senate Meeting. It was seconded and passed unanimously.

- Institutional Update, (Provost Vayda)

The Provost thanked Faculty Senate President Michael Graves for inviting him to provide an update. Enrollment is high with a significant number of transfers. This is very healthy due to the demographic decline in New England. Graduation enrollment numbers have been flat for the last five years. It is in our interest to row graduate enrollment. Growth is attributable to the work done by faculty.

- Accommodate Platform Demonstration, (Brandon Drake, Assistant Director for Assistive Technology)

Brandon Drake provided a brief overview emphasizing that the document is a draft. There are no trainings right now so as not to confuse people at a later time when things go live.
