When preparing NIH research proposals, please follow the [Research Instructions for NIH and Other PHS Agencies \(Forms Version I Series\)](#) along with any specific FOAs, NOSIs, or Related Notices. The guidance provided in the FOA/NOSI will supersede the general Research Instructions. It is **critical** to verify the [Institute & Center \(IC\)](#) you are targeting is participating in the Parent Announcement. This checklist highlights, not replaces, the general Research Instructions. **Please consult the guidelines for complete instructions.**

**REQUIRED FORMATTING**

- All documents must be submitted in PDF format (100MB or less)
- Use Arial, Helvetica, Palatino Linotype or Georgia type - 11 point font or larger. (Smaller font may be used for figures, graphs, diagrams, charts, tables, figure legends and footnotes but must be legible)
- ½ inch margins all around for all pages
- Filename: Length of uploaded document titles must not be more than 50 characters using the following characters: A-Z, a-z, 0-9, underscore, hyphen, space, period, parenthesis, curly braces, square brackets, tilde, exclamation point, comma, semi colon, apostrophe, at sign, number sign, dollar sign, percent sign, plus sign, and equal sign.
- No information in header or footer - page numbers for the footer will be system-generated.
- Follow the [NIH Table of Page Limits](#)
- Hyperlinks/URLs are only allowed when specifically noted in the guidelines but are otherwise strictly prohibited. When allowed, you must hyperlink the actual URL text, so it appears on the page rather than hiding the URL behind a specific word or phrase (hypertext).
- Electronic signatures on PDF attachments within your application are not allowed. Standard forms requiring electronic signatures should be flattened prior to upload.

<b>Project Summary/Abstract</b>	<ul style="list-style-type: none"> <li>Limited to 30 lines of text</li> <li>Do not include proprietary, confidential information or trade secrets</li> </ul>
<b>Project Narrative</b>	<ul style="list-style-type: none"> <li>3 sentence max</li> </ul>
<b>References Cited</b>	<ul style="list-style-type: none"> <li>Should include references cited in the Research Plan and Human Subject sections</li> <li>Active hyperlinks in this section are not allowed</li> <li>Citations that fall under the Public Access Policy (authored or co-authored by the applicant and arose from NIH support) provide the NIH Manuscript Submission reference number or the PubMed Central (PMC) reference number.</li> <li>Citations not covered by the Public Access Policy, but are publicly available in a free, online format may include URLs or PubMed ID (PMID) numbers along with the full reference</li> </ul>
<b>Facilities &amp; Other Resources</b>	<ul style="list-style-type: none"> <li>Describe the scientific environment in which the research will be done and how it contributes to the probability of success (e.g., institutional support, physical resources, and intellectual rapport).</li> <li>If there are multiple performance sites, describe the resources available at each site.</li> <li>Early Stage Investigators (ESI) should include description of institutional investments such as resources for classes/travel/training, collegial support, logistical support, and financial support.</li> </ul>
<b>Equipment</b>	<ul style="list-style-type: none"> <li>List major items of equipment already available</li> <li>If there is no equipment items to list, upload a pdf with the “Equipment” heading and state “No major equipment will be used to complete the proposed work”.</li> </ul>
<b>RR Performance Sites</b>	<ul style="list-style-type: none"> <li>Include all project/performance site location(s) – generally the applicant organization is the primary location.</li> <li>UEI is a required field (UML UEI: LTNVSTJ3R6D5)</li> </ul>
<b>RR Key Person Profile (including Bio)</b>	<ul style="list-style-type: none"> <li>NIH now requires the use of the <a href="#">Biographical Sketch Common Form</a> prepared in SciENcv – see OSP website for detailed instructions on how to complete the new form.</li> <li>You must link your eRA commons account to your SciENcv account, and link your eRA commons ID with your ORCID ID</li> <li>Once you have certified in SciENcv and downloaded the document, you cannot edit anything except the title, or it won’t be compliant</li> <li>You must still include your eRA Commons ID in the “Credential, e.g., agency login” field</li> <li>Current and Pending Support is not required at proposal stage unless specified in the NOFO</li> </ul>
<b>Budget</b>	<ul style="list-style-type: none"> <li>Must draft budget using <a href="#">OSP Internal Budget Template</a> which you will data enter in portal once OSP approves</li> <li>Generally, you must use a <a href="#">Detailed Budget</a> if you are applying for more than \$250,000 per budget period in direct costs, and you must use the <a href="#">Modular Budget</a> if you are applying for less than \$250,000 per budget period in direct costs. Personnel with 9-month appointments should calculate the monthly salary for the current NIH cap and then multiply that amount by 9 to determine what to use as the base salary for the OSP Internal Budget Template.</li> <li>○ Full-time Academic RAs require associated tuition and fees. (\$10K per 9 academic months)</li> <li>○ UML’s equipment acquisition threshold is \$5K</li> <li>○ Confirm whether there is required travel for conferences or meetings</li> <li>○ Absolutely no cost share unless solicitation requires</li> <li>○ Cognizant Federal Agency Field - DHHS, Edwin Miranda, 212-264-2069</li> <li>○ Include Data Management and Sharing Costs (as applicable). <p><b><i>Consortium Justification (Used for Modular)</i></b></p>	<ul style="list-style-type: none"> <li>• If you have a subcontract(s), include total costs (direct + F&amp;A) rounded to the nearest \$1,000 for each and identify any foreign consortiums.</li> <li>• Should include the name, role, and number of person-months devoted to this project for every person on the project.</li> <li>• <a href="#">NIH Specific Consortium Justification Template</a></li> </ul>
<p><b><i>Additional Narrative Justification (Used for Modular)</i></b></p>	<ul style="list-style-type: none"> <li>• Include explanations for any variations in the number of modules requested annually.</li> <li>• Describe any direct costs excluded from the total direct costs (such as equipment, tuition remission) and any work being conducted off-site, especially if it involves a foreign study site or an off-site F&amp;A rate.</li> <li>• <a href="#">NIH Specific Additional Narrative Justification Template</a></li> </ul>

<b><i>Research Strategy</i></b>	<ul style="list-style-type: none"> <li>• Organize the Research Strategy in the specified order starting each section with the appropriate heading – Significance, Innovation, Approach.</li> <li>• Detailed guidance and requirements provided in the <a href="#">Research Instructions for NIH and Other PHS Agencies</a></li> </ul>
<b><i>Progress Report Publications List</i></b>	<ul style="list-style-type: none"> <li>• Should be included for renewal submissions</li> </ul>
<b><i>Vertebrate Animals</i></b>	<ul style="list-style-type: none"> <li>• Must be included if Vertebrate Animals are being used</li> <li>• Be sure to address 1.) Description of Procedures 2.) Justification 2.) Minimization of Pain and Distress 4.) Project Performance Sites 5.) <b><i>Select Agent Research</i></b>	<ul style="list-style-type: none"> <li>• Include if your proposed activities involve the use of <a href="#">select agents</a> at any time during the proposed project period, either at the applicant organization or at any performance site</li> </ul>
<b><i>Multiple PD/PI Leadership Plan</i></b>	<ul style="list-style-type: none"> <li>• Must be included if multiple PIs have been designated in the RR Key Person Profile section</li> </ul>
<b><i>Consortium/Contractual Arrangements</i></b>	<ul style="list-style-type: none"> <li>• Must be included if you have consortiums/contracts in your budget</li> </ul>
<b><i>Letters of Support</i></b>	<ul style="list-style-type: none"> <li>• Include letters necessary to demonstrate the support of consortium participants and collaborators such as Senior/Key Personnel and Other Significant Contributors</li> <li>• Consultants letters should include rate/charge for consulting services and level of effort/number of hours per budget period anticipated. **HOW TO ENTER MULTIPLE INDIRECT COST (IDC) RATES IN GRANTS.GOV**

UML's Negotiated Indirect Cost (IDC) Rate Agreement has different yearly rates in the coming years. Multiple rates may apply to a single budget period due to how the fiscal year falls within the period of performance. The split rates must be detailed out on proposal budgets. To split the rates, follow the steps below:

1. Confirm the correct dates for the applicable budget period are entered in row 3 of the budget template.

2. Calculate the IDC bases.

- Go to the IDC section of your internal budget and locate the rate information on Row 76. This will tell you how many days of the year apply to each rate.

75	Indirect Cost Type	Indirect Cost Rate	Rate Information	Indirect Cost Base (\$)
76	Modified Total Direct Costs (MTDC)	On Campus - Research	273d at 57.5%   92d at 58%	142,268

- Using that information, calculate what percentage of the year is applicable to each rate by dividing the number of days by 365.

Rate Information
273d at 57.5%   92d at 58%

$273 \text{ days at } 57.5\% \quad 273/365 = 0.7479452054794521$   
 $92 \text{ days at } 58\% \quad 92/365 = 0.2520547945205479$

- Take each *value* calculated above and multiply by the Indirect Cost Base (\$) provided in the temple:

Rate Information	Indirect Cost Base (\$)
273d at 57.5%   92d at 58%	142,268

$273/365 = 0.7479452054794521 * \$142,268 = \$106,408.67 = \text{MTDC for 273 days at 57.5\%}$   
 $92/365 = 0.2520547945205479 * \$142,268 = \$35,859.33 = \text{MTDC for 92 days at 58\%}$
