Household Hazardous Waste Day

The collection of syringes, needles and lancets (“sharps”) will be available at Household Hazardous Waste Day (HHWD). Lowell residents may place their used “sharps” in a sharps container or a puncture proof container (such as a liquid detergent or bleach container) with a screw-on lid – label “SHARPS” and drop off at the collection event.

HHWD is held two times each year; Spring and Fall. The location of HHWD is at Cawley Stadium (off Douglas Rd). Call Solid Waste & Recycling Office at **978-674-4309** for dates of these events or check the Solid Waste and Recycling website: www.LowellRecycle.org

Safe disposal of needles, syringes, and lancets

New Regulation

Effective July 1 2012, a statewide ban prohibits the disposal of needles, syringes and lancets (referred to as “sharps”) in household trash.

Why the ban?

The Massachusetts Department of Public Health (MDPH) took this step to reduce sharps injuries and the incidence of disease, via amendments to its medical waste regulations [105 CMR 480.000: Minimum Requirements for the Management of Medical or Biological Waste (State Sanitary Code Chapter VIII)]. Concern about injuries led to the ban. According to MDPH, worker injuries from sharps in household trash have an ongoing concern for the solid waste industry.

It is illegal for anyone in Massachusetts to discard sharps in household trash

Household Hazardous Waste Collection Day/Event

These collection events are held 2 times each year – Spring and Fall. They are held at Cawley Stadium from 9am until 1pm. If you do not have Sharps disposal containers, you may place your used “sharps” in a puncture-proof container (such as a liquid detergent container) with a screw-on lid -label "SHARPS"-and drop-off at collection event.

Mail – Back Disposal *(Includes a fee)*

When use of a local sharps collection program is not convenient, you may purchase a **postage-paid mail-back kit** to mail your sharps to a medical waste handler for disposal. Walgreens Pharmacy in Lowell located on **54 Plain Street** and **1161 Bridge Street** sells these kits containing a mail-back shipping box that can be returned for disposal via U.S mail.
