2.1. Library Advisory Committee and Research Production & Performance Committee Collaboration (Dennis Christodouleas & Thomas Shea). Thomas Shea shared that RPPC will be requesting departmental desires for library resources that support R1 and the Graduate School is number one on his agenda. President Meehan is interested in sharing and consolidating each campus' resources.

## 3. Presentations

- 3.1. Web Services Update (Sarah Eisenklam) Sarah Eisenklam & Jenny Lisle provided a "Digital Strategy Presentation" to highlight the need for making our websites and content accessible, including all documents (CVs included), images, videos, bios, announcements, catalog & marketing content, academic and program pages. They cautioned that <u>universities that have been sued</u> and noted that there is a delay when you submit your content because they are checking it for accessibility. All images require alt text for screen readers. There are tools you can use to create accessible documents to expedite the accessibility process. They noted that our website is designed to be accessible and encouraged that if you are uploading a document, you should think about making it web content instead. Further, each department and/or program requires a Web Maintainer to make website updates. Web Editing Training is provided on a regular basis and can be set up by contacting <u>cms\_training@uml.edu</u>. They asked senators to share the PPT presentation with their departments.
