Voted to accept the report of the Committee appointed to devise a method of dividing the money for the support of Schools amongst the several School Districts, as also to consider whether it is expedient to appropriate any part of the money grant for the support of Schools, exclusively to the Irish Children in said town, which is as follow, viz;

"The committee appointed to devise a method of dividing the money raised by the town for the support of Schools, submit the following report.

That three eighths of the money shall be divided in the proportion of the number of scholars over four years of age, in each district, and the remaining five eighths, in the proportion of the tax paid by each district. If however, any district shall draw by the above proportion less than fifty dollars, and the such district shall receive fifty dollars, and the rest shall be divided by the above proportions, among the other districts. The division shall be made by the assessors, and it shall be the duty of the prudential committees to furnish the assessors with the number of scholars in their respective districts, of suitable age, on the first day of May each year.

It is intended that all persons over four years of age who are likely to attend school either public or private shall be counted and no others.

Your committee further recommend, that the school committee be authorized to expend at their discretion, and in the way they shall deem expedient, any sum not exceeding fifty dollars of the money raised for the support of schools, for the instruction of the children of the Irish Families in this town. This provision to apply to this year only.
