### Meeting of Undergraduate Policy Committee (UPC) of Faculty Senate

#### 5. New Curriculog Processes (Kerry Patenaude)

Faculty Senate Coordinator Kerry Patenaude provided a brief overview of the new approval processes in Curriculog. Everyone with a UML email address can view all steps of all proposals in Curriculog. Originators, Department Chairs/Program Coordinators, College Curriculum Committees, and College Deans will approve proposals directly in Curriculog. UPC and GPAC members will be notified in the week prior to their meeting to review proposals attached to the agenda in Curriculog. UPC and GPAC will discuss proposals and vote during their respective meetings. Committee members may comment in Curriculog if they wish, but only the Chair will enter the results of the vote in Curriculog. UPC and GPAC members should not vote directly in Curriculog. Key issues discussed: Committee members want departments to note if there is a similar course already in existence and how the proposed course differs. Courses at 3000/4000-level must have a pre-requisite. Catalog descriptions must be clear. If College Writing II is a pre-requisite then College Writing I is implied. Syllabi must be included. This semester Kerry will be building help text on the Faculty Senate website.

#### 6. Proposal to add new electives to the Minor in Disability Studies (Michael Geiger on behalf of Ashleigh Hillier)
