### Meeting of Undergraduate Policy Committee (UPC) of Faculty Senate

2. Announcements
  1. **B.S. in Nursing – Outcomes** (Laurie Soroken). Mike Geiger shared existing and updated program outcomes. The department is currently completing accreditation. <https://uml.curriculog.com/proposal:1467/form>
  2. **Internship Language** (Greg Denon / Sal Mazzone). With the Chancellor's commitment to career-connected opportunities, a process is needed so that international students are included. International students are not allowed to work off-campus unless it is through curricular training. For students on an F1 visa the government will ask if the work experience is an integral part of the established curriculum and a required component of the course. ISSO is requesting that each department and program look at course descriptions for intern-like courses, to make it crystal clear when a work experience is a requirement of the course. If a course does require a work experience (not an option, but THE requirement) then ISSO proposes adding two short statements to the course description (see slides). This will allow ISSO to provide the government with required information for international students. Without this language, international students would not be allowed to participate in career-connected opportunities.

The committee discussed potential timelines for implementation by 2025. ISSO will bring this request to GPAC next week.
3. Policy Proposals
  1. **Exercise Science Admission Criteria** for Transfer Students – Internal and External (Nicole Champagne). Mary Kate Keyes presented the proposal to change the required GPA to 2.5 and one semester of the science sequence, only for clinical or pre-health option. Formerly required GPA 2.7 and two semesters of the

science sequence. This change is in line with other programs in the college and will go into effect for FA24. Motion to approve by Mary Gormley, second by Carol Myers. Motion approved unanimously (yes 8, no 0, abstain 0)

New Dept Chair Nick Evans provided insight on the Philosophy course proposals. The dept is taking introductory steps to change their curriculum. Namely, to offer introductory courses, add College Writing pre-requisites, rename courses to be more intelligible, and inactivate duplicative courses. Next steps will include adding Topics in Philosophy for majors only to build community, replacing Communications with a Public Philosophy concentration to encourage movement and activism, adding a Religion Studies person for that track, new courses sequences, better collaboration with North Campus and inter-college connections, and more.

Motion to approve all course proposals, with the exception of COMP.4500, COMP.4510, and ENGL.3690, by Art Mittler, second by Mary Kate Keyes. Motion approved unanimously (yes 8, no 0, abstain 0)

## 6. Discussion

1. Senate Feedback on Proposed Pre-requisite Policy – The committee discussed the initial feedback on the proposed pre-requisite policy. Highlights included:
  - The importance behind the intent of the policy; the purpose of pre-requisites is to scaffold knowledge, including reading, writing, and analysis skills.

- Course levels are designed to be introductory, to reinforce, or to master.
  - The importance of looking at our degree pathways and looking at what other universities are doing. Curriculum mapping is key.
  - A pre-requisite might be:
    - College Writing, which provides important college skills
    - “Music majors only”
    - Instructor permission
  - The importance of thinking about a smart, reasonable timeline to properly address all courses.
  - The best time for the Registrar’s Office would include an August 1 deadline.
  - The possibility of addressing 4000-level courses first, then moving on to requirements and electives.
  - Next steps will be to clarify what UPC is proposing, why it is being proposed, and defining terms.
2. The Role of UPC – The committee discussed UPC’s role in building a more engaged senate. There is a need to clarify the role of faculty oversight at this level. One goal is to create a handbook to delineate roles & responsibilities, what we do, why we do it. This effort will support onboarding for faculty senators. The committee will discuss further at the December 11 meeting.
